

SUNSET REVIEWS 2018 – 2019

Sunset Reviews are scheduled for 2018 and legislation is scheduled for the 2019 session (to start in the Senate)

1. 2018-2019 Sunset Review Professional Review Committees

The Sunset Review is a review of the Colorado Professional Review Act, Article 36.5 of Title 12, C.R.S.; including definitions; use of professional review committees; establishment of professional review committees; hospital professional review committees; definition and rules relating to governing boards registering and reporting to the division; immunity from liability; limitations on liability relating to professional review actions.

2. 2018-2019 Sunset Review of Medical Board, Colorado, including an Analysis of Physician Responsibilities Related to Recommendations for Medical Marijuana.

The Sunset Review is a review of the Colorado Medical Practices Act, Article 36 of Title 12, C.R.S.; which includes the powers and duties of the medical board, practice of medicine, qualifications for licensure, foreign teaching physician license; anesthesiologists assistants; physician assistants; foreign medical school graduates; licensing panel; Skolnik Act; license fees; pro bono license; reentry license; unprofessional conduct; prescribing opioid antagonists, disciplinary actions by board and immunity; confidential agreements to limit practice; appeal of final board actions; physician training licenses; peer health assistant programs; unauthorized practice and penalties; postmortem examinations by physicians; professional services corporations, limited liability companies, and registered limited liability partnerships for the practice of medicine; mandatory reporting and immunity; inactive license; physicians obligations to protect medical records; medical marijuana recommendations.

3. 2018-2019 Sunset Review Medical Marijuana Program and Medical Marijuana Code

This review pertains to the sale of medical and retail marijuana at Article 43.3, of Title 12, C.R.S. and Article 1.5, Title 25, C.R.S., including power and duties of the agency, qualification of licensees; qualifications for a license of a medical marijuana center, qualifications of optimal premises cultivation license; and rules on medical marijuana-infused products.

4. 2018-2019 Sunset Review Controlled Substances, Recordkeeping and Licensing Functions

This review pertains to the recordkeeping and licensing functions of controlled substances, Article 80, Title 27, C.R.S., in addiction programs and researchers including license required for controlled substances; qualifications for license; denial, revocation or suspension of license and other disciplinary actions; exemptions; records to be kept; enforcement and cooperation; confidential records. Addiction program means a program licensed under this statute for detoxification, withdrawal or maintenance treatment of addicts.

5. 2018-2019 Sunset Review Hemodialysis Clinics and Technicians, Regulation of

This review is the review of the regulation of dialysis treatment clinics and training for hemodialysis technicians, Article 1.5 of Title 25, C.R.S.

6. 2018-2019 Sunset Review Podiatry Board

This review is of the continuation of the podiatry board, Article 32 of Title 12, C.R.S.
